Long-Term Care Financial Review to be Released End of September

Thank You Volunteer Surveyors!

The OSA Long-Term Care Survey wrapped up over the past month thanks to our province-wide team of nearly 500 Volunteer Surveyors. They collectively contributed over 18,000 hours of volunteer work and interviewed over 29,000 residents in 297 care homes across British Columbia. The results of the Long-Term Care Survey will be published in a report scheduled to be released in November.

Independent Senior Centres: Connecting and Supporting Older Adults in Metro Vancouver

(Gerontology Research Centre, Simon Fraser University)

As our population ages and becomes more diverse, the health and social needs of older British Columbians are becoming more fluid and complex. Senior centres play an important role in providing health promotion programs, social services, and recreational activities that enhance the health and wellbeing of community-dwelling older adults.

Wildfires and Older Adults: A Scoping Review of Impacts, Risks, and Interventions

(International Journal of Environmental Research and Public Health))
Climate change is leading to worsening disasters that disproportionately impact older adults. While research has begun to measure disparities, there is a gap in examining wildfire-specific disasters. To address this gap, this scoping review analyzed literature to explore the nexus of wildfires and older adults.

Validity and Accuracy of the Tilburg Frailty Indicator Part B for Identification of Frailty in Older Adults Consulting a Rural Geriatric Medicine Clinic

(Cambridge University Press)

This study provides evidence to support the use of Tilburg Frailty Indicator Part B (TFI-B) to determine frailty in older adults in a North American context. The results show that the TFI-B can be used as a quick screening tool to determine frailty, given its lower administration burden compared with the Fried's Frailty Phenotype (FFP). Clinicians should use a score of < 5 on the TFI-B to rule out frailty, given its high negative predictive value (91.95%).
