Updated Long-Term Care and Assisted Living Directory Released

The Office of the Seniors Advocate has released its updated directory of long-term care and assisted living homes. The directory provides detailed information on over 400 publicly subsidized facilities in a searchable, online format and includes information on a number of measures including: funded care hours, number of beds and room configuration, spending on food, medication use, use of physical restraints, how much physical/occupational and recreational therapy is provided, complexity of care in the resident population, licensing complaints, reportable incidents and inspection reports.

Facility Level Results of Long-Term Care Survey Now Available

This year's update of the Long-Term Care and Assisted Living Directory includes the results of the 2023 OSA Long-Term Care Resident and Visitor Survey. The survey, undertaken by over 500 volunteers, captured the experiences of residents of 297 publicly subsidized long-term care homes in B.C. Survey questions included topics such as food quality, staff responsiveness and personal autonomy. Canadian Dental Care Plan Details Released

The Government of Canada has unveiled some details of the long-awaited Canadian Dental Care Plan, which will help make oral health care more affordable for uninsured. The program will be rolled out in a phased approach over the coming months, starting with seniors aged 87 and above.

Recent Research

Understanding the Patient Experience of Foreign-Born Older Adults: A Scoping Review of Older Immigrants Receiving Health Care in Canada

(Cambridge University Press)

In Canada, foreign-born older adults (FBOA) have a higher prevalence of chronic conditions and poorer self-reported physical and mental health than their Canadian-born peers. However, very little research has explored FBOAs' experiences of health care after immigration. This review aims to understand the patient experiences of older immigrants within the Canadian health care system.

Impact of health and transportation on accessing healthcare in older adults living in rural regions

(Transportation Research Interdisciplinary Perspectives)

Living in rural areas poses challenges to accessing healthcare, often requiring individuals to travel to major cities. This study examined the impact of health and transportation among older adults using no healthcare services, family doctor services, and medical specialist services, and compared to those living in rural and small population centers.

Alternatives to the transfer of long-term care patients to emergency departments: a new kind of house call?

(Canadian Journal of Emergency Medicine)

Long-term care residents have unique care needs such that ageing, medical complexity, frailty, polypharmacy and increasing care requirements have all been associated with a higher likelihood of emergency department transfer for illness or injury. Similarly, advance care planning and advanced directives have been shown to decrease the rate of emergency department transfers for long-term care residents. Previous research has demonstrated that nursing home residents may not even want transport to the emergency department, and patients and families, and nursing home staff desired shared decision-making.
