File your Taxes to Receive Benefits

Tax season is here! Did you know that eligibility for many government programs and supports depend on your income tax return?

File before the April 30 deadline to get refunds quickly and avoid missing out on important government benefits like the Guaranteed Income Supplement, Shelter Aid for Elderly Renters, or the BC Renter's Tax Credit.
